Harbor House Recovery Home - Harbor House Recovery Home is a transitional sober-living housing program. The objective is to take in homeless individuals struggling with substance abuse issues and return sober, self-sufficient to the community. Clients first focus on their sobriety and then focus on their employment.

Project Detour - Project Detour is a transitional housing program for women who have a history of substance abuse (primarily opiates and alcohol), have been in jail, and are at risk of being homeless.
